RE: CONTINUING EDUCATION FOR ALL LICENSEES

This is an important reminder to all Florida licensed title agents. §626.2815, F.S. states in pertinent part "...in the case of title agents, beginning with the renewal of appointments in 1995, and thereafter, each person subject to the provisions of this section must have completed a minimum of 14 hours of continuing education courses each year or 28 hours of continuing education courses every two years in courses...approved by the department." (Emphasis added.)

The vast majority of the title agent licenses currently held in Florida expire on your birth month of 1995. If you were born in January, you have 12 months to earn your necessary 28 C.E. hours.

Old Republic has presently applied to be able to supply some of these hours for our agents, however, this is a protracted process. The vast majority of the required hours will need to be earned through other sources. The Florida Land Title Association (1-800-552-1065) will sponsor eight hours in Orlando on January 17, 1994 and another eight hours in Tallahassee on February 24, 1994. These seminars are open to both members and non-members.

Please be careful and timely earn your continuing education hours.

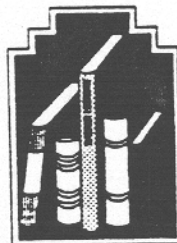
