The prices (or any portion thereof) may not be extended to any other party. You may not under any circumstances sell, assign or otherwise transfer (including but not limited to, third party billing) the benefit of this pricing to any other party. Failure to abide by this provision may result in immediate termination of your participation in the Program. With the exception of custom freight pricing agreements between FedEx and Agent, this Agreement supersedes all Pricing Agreements and Addenda, if any, for FedEx Express and FedEx Ground services between FedEx and Agent for the designated U.S. Payor account numbers relating to the services and package types covered by this Agreement.</li> <li>2.
